**Our Lady of the Lake Parishioner**

The family is registered in the parish and worships with the parish community on a weekly basis. In order to verify parishioner status, envelopes should be used whenever attending Mass, regardless of contribution. Families who give electronically need to mark the envelopes accordingly and place them in the basket on Sundays. Placing an envelope in the basket is also a visual sign to the children of the importance of giving. The registered family also contributes time and talent to parish and/or archdiocesan activities/ministries.

The family volunteers a minimum of 10 hours in the school and or parish (excludes fundraising) – AND - the family volunteers a minimum of 20 fundraising hours in the school year. The family provides additional support by either:

- Auction purchase/underwriting/sponsorship of \$1,000 OR
- Scrip purchases totaling \$5,000 or more OR
- Buy-in Participation/other OLL school sanctioned donation of \$1,000 or more OR
- Endowment contribution of \$1,000 or more
- \$100 will be charged for every incomplete fundraising or volunteer hour

Our Lady of the Lake Catholic School uses the FACTS Tuition Management Program to collect tuition and fees. Families may choose to pay their entire tuition and fees for the year at one time in the office (7 days prior to due date 2021). Families new to the school will receive a FACTS tuition form with this contract. Families may also choose a quarterly or monthly option. Quarterly and monthly payments to FACTS are due beginning in June and ending in April. Payments are via ACH withdrawal through checking, savings, or credit card. **Tuition Payment Options**

- Plan A    FULL PAYMENT One tuition payment on or before June 10<sup>th</sup> 2020
- Plan B    QUARTERLY PAYMENTS on or before the 15<sup>th</sup> of June, September, December, and April
- Plan C    MONTHLY Eleven monthly payments by the 15<sup>th</sup> of the month, June through April
