**Additional Terms and Conditions of Tuition:**

**ACTIVE OLL COMMUNITY MEMBER:** To qualify for the active OLL Community Member Credit, families are required to volunteer a minimum of 30 hours for the OLL Community and contribute \$1,000 to any school fundraising event.

If families apply for the credit and do not meet the conditions of Active OLL Community member by May 31, 2026, they will be charged as follows:

- \$100/hour for each uncompleted hour per student and \$1,000 donation (or balance outstanding).

Tuition will be paid in one of the following manners:

- **Full payment in advance:** Pay the entire amount by **June 1, 2025.**
- **Quarterly installment payments:** Payment will be due: June 2025, Sept. 2025, January 2026, and April, 2026.
- **Eleven installment payments:** Monthly payments June 2025 through April 2026

**2025-2026 Enrollment and Annual Fees:**

**Enrollment Student Fee: \$400.00** - All returning students will be required to pay the re-enrollment fee at the time of enrollment registration. All new students paid a \$300 registration fee and will pay a \$100 enrollment fee once a spot has been offered.

**Additional Student Fees:** These mandatory fees are paid in September 2025.

- Parent Association- Family Dues: \$60 per family
- Parent Association- Per student Auction Fee: \$20
- Parent Association- Per Student Auction Project Fee: \$30
- School Activity Fee: \$75 per student
- School Planner Fee \$6 per student in 3rd-5th grade

\*Families have until May 31, 2025 to withdraw from OLL for the 25-26 school year without a financial penalty. Families that withdraw between 6/1 and 9/2 will be assessed a late withdrawal fee of 25% of their contracted tuition. Families that withdraw mid year will be responsible for a withdrawal fee as detailed in our Student and Parent Handbook.

\*Our Lady of the Lake reserves the right to withhold a re-enrollment packet as directed by the Administration for various reasons, including but not limited to, outstanding financial obligations.

\*Acceptance of a seat within a grade at Our Lady of the Lake Catholic School confirms your acceptance of this tuition contract. Any late tuition payments may be assessed a monthly late fee.
